

Covid 19 regulations for the EYC Speed in Bochum:

People who do not comply with the following regulations will be excluded from using the sports facility in the interest of all visitors/participants:

1. **STOP:** People suffering from COVID-19, showing symptoms of a COVID-19 infection currently or within the previous 14 days, or who have had contact with persons with a corona infection or have been in a risk area declared by the RKI, are not allowed to participate in the competition or to enter the event area! For visitors arriving out of “areas of variant of concern”, “high incidence areas” or “risk areas” in the past 10 days, must follow the current rules for border crossing and testing.

2. Observe the cough and hygiene etiquette in the facility and leave the facility if you notice any symptoms of illness!
3. Always keep a distance of 1.5 meters to other people. Avoid physical contact wherever possible. Observe hygiene and disinfection measures at all times. Wash your hands thoroughly with soap and use disinfectant dispensers.
4. The wearing of a **FFP2**- mouth and nose mask may only be interrupted within the buildings for the practice of sports activities in a competition context. Wear your face mask permanently, also in the outside area of the premises.
5. When using the toilets, the rules distance and hygiene measures must be observed. It is not possible to use the shower facilities. Please arrive at the venue in your national dress.
6. Spectators are not allowed to enter.
7. Entering the facility is only permitted after successful accreditation. For detailed information see: “Information for Athletes/Coaches – Accreditation.”

The legal basis of the data processing is Article 6 Paragraph 1, Subparagraph 1, Letter f DSGVO (General Data Protection Regulation), since the responsible operator of the facility has a vested interest in preventing the uncontrolled spread of COVID-19 infections among its guests/members; in addition, the data collection is carried out in the interest of other guests and employees.

In certain circumstances, the data processing may also be based on an obligation under Article 6 Paragraph 1 Letter c DSGVO in conjunction with § 9 of the Fifth Bavarian Infection Prevention Measures Ordinance and with No. 4. b) Framework Hygiene Concept Sport (Joint Announcement of the Bavarian State Ministries of Health and Care and of the Interior, for Sport and Integration of May 29, 2020, Ref. G51b-G8000-2020/122-346; published in BayMBI. 2020 No. 306 of June 2nd, 2020), in particular if a case of § 9 Paragraph 4 No. 3, Paragraph 5 Sentence 2 and Paragraph 6 of the 5th BayIfSMV is given.

Another legal basis for the data processing is Article 6, Paragraph 1, Subparagraph 1, Letter d DSGVO (processing of personal data to protect vital interests of the data subject or another natural person). This includes the processing of personal data for the purpose of monitoring epidemics and their spread.

As a data subject, you have the right of access to and the right to correct your personal data, as well as the right to delete your data after the above-mentioned retention period has expired. For this purpose, you can contact the person in charge using the above-mentioned contact details; the data will be deleted after the retention period has expired, even without your intervention.

As far as there is no obligation to collect your data on the basis of BayIfSMV, you have the right to object to data processing on the basis of your particular situation.

2. RULES

1. ENTRY TO GERMANY

Attached you will find the current "Information on the designation of international risk area" from RKI. It's your responsibility to check if you are allowed to travel to Germany. Please also see the link for the following website: <https://www.bundesgesundheitsministerium.de/coronavirus/current-information-for-travellers.html>

Here you will also find relevant information if you are entering the country from "areas of variant of concern", "high incidence areas" or "risk areas". Invitations from the organizers make border crossing out of these areas possible. Therefore, check the information you received via mail.

2. PERSONAL EQUIPMENT AND HEALTH CHECKS

Athletes/caregivers/coaches/DAV officials/volunteers will be examined by the Covid-19 representative if an acute respiratory illness is suspected. The sharing of material (bottles, towels, masks, glasses, shoes, etc.) is strictly prohibited.

3. TECHNICAL MEETING

In order to explain the scope of the measures necessary to contain the COVID-19 pandemic, there will be a virtual Technical Meeting on Monday, May 31, 2021 at 19:00 for all team members. In addition, there will be a Technical Meeting on site the day before the competition (Friday, June 4., 2021 at 9:30), where only one team member of each nation may be present.

4. OFFICIAL BOARD

In order to consistently adhere to the distance regulations, the official board is provided virtually.

5. AWARD CEREMONY

Please inform your athletes about the procedure for the award ceremony: - Athletes must wear a FFP2 mask during the award ceremony.

The awarded athletes get an intense briefing shortly before the ceremony. More information are given in the technical meeting.

Information for athletes/ coaches:

1. Stop: Covid 19 Testing

The organizer requires all participating athletes, coaches and team officials to present a valid negative Covid 19 antigen test at any time during the event. All other tests will not be accepted! Antigen Tests have a maximum validity of 24 hours (calculated from the time when the test is taken). When entering the venue, you are required to show your medical certificate of the negative Antigen- Test (in English or German).

A free possibility for testing is provided opposite to the stadium between 7:00 and 08:30am. If this option is planned to perceive, each test has to be registered via:

During the time of the test, free short time parking is possible.

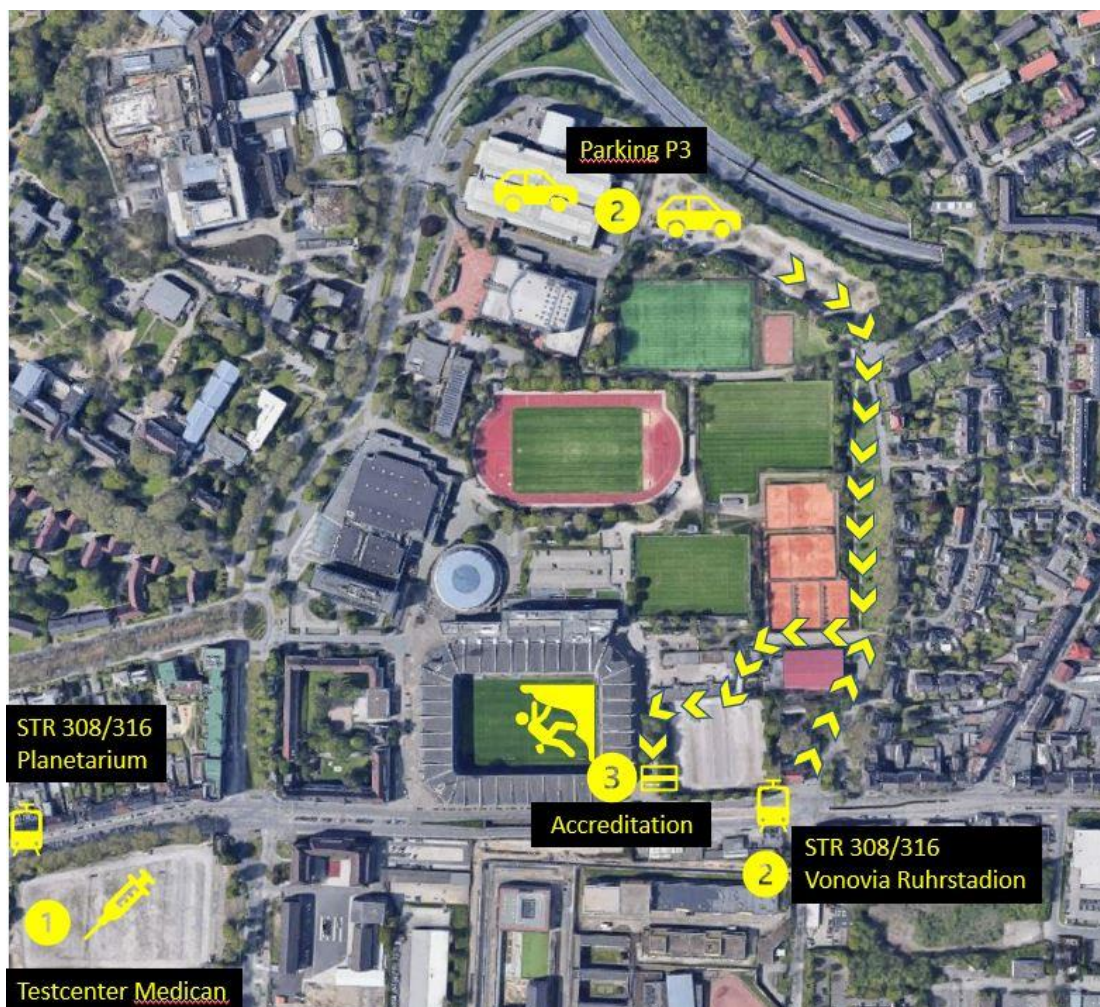


Figure 1: Location Plan

2. Stop: Arrival

Arrival by car: parking Stadionring 26, 44791 Bochum. 3€ per day, cashless payment only (EC- card or credit card possible).

Please follow the signposted path to the accreditation office. See floorplan (Figure 1)

Important: Only one entrance for sport climbing.

Arrival by public transport: via tram -> station "Vonovia Ruhrstadion"

- STR 308 direction „Schürbankstraße“
- STR 316 direction „Heinrichstraße“

After arrival, please follow the signposted path to the accreditation office. See floorplan (Figure 1). Attention, the direct way is not possible.

Important: Only one entrance for sport climbing.

3. Stop: Accreditation

Before entering the stadium, each have to pass the accreditation office at the east side of the stadium (blue container). Here you show your negative covid test and your passport (see 1. Stop Covid 19 Testing). In return you receive your accreditation. It's not possible to leave the venue and enter again.

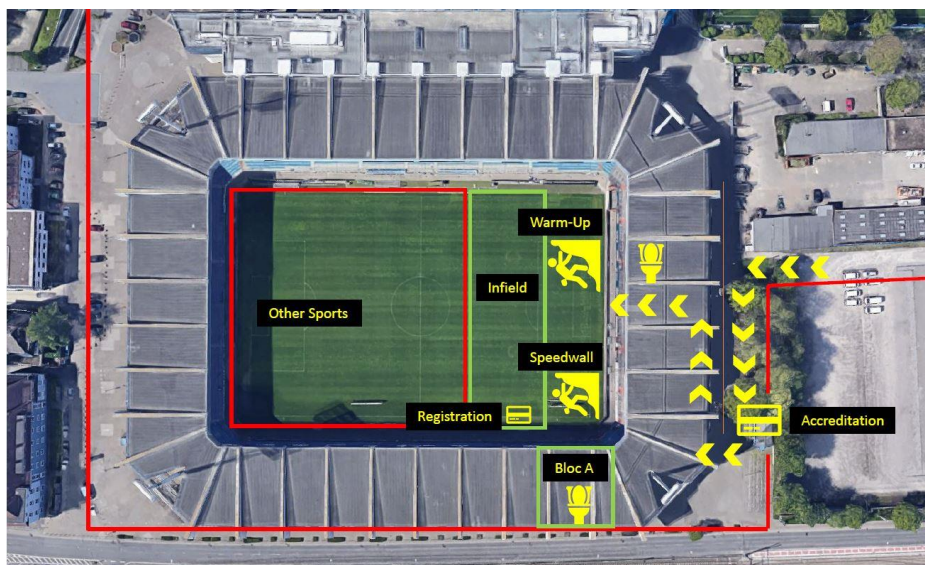


Figure 2: Stadion overview

General common area

The general common area includes the infield, warm up area and the area of retreat. Each sport receives an individually assigned block in the stands at the Vonovia Ruhrstadion, with its own sanitary facilities. During breaks in the competition, the athletes can stay there. Distance regulations have to be followed. Provided for climbing is block A.

There is no free catering for athletes and coaches. Water is available.

You can move around freely in the "Athlete's Common Area". For warming up, there is an area at the backside of the bouldering wall. (see figure 2: Stadion overview). The use of the showers is not permitted.

Registration:

The registration is located at the infield next to the speed wall. Contrary to the accreditation, we are asking one official per team to register all athletes at once.

Call zone:

For your attempts, please arrive in time at the call zone for your run. During the stages, stay inside the call zone between your races.

Climbing procedure:

The FFP2 mask must also be worn the entire time during tying in and direct preparation for the run. Only after being tied in and after the volunteers left the stage, you are allowed to remove the mask. Directly after your race, putting the mask on is required.
